**Purpose.** The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services. They also inform HUD, families served by the PHA, and members of the public of the PHA's mission, goals, and objectives for serving the needs of low-, very low-, and extremely low- income families.

**Definitions.**

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers (HCVs) and was designated as a high performer on both the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments if administering both programs, SEMAP for PHAs that only administer tenant-based assistance and/or project-based assistance, or PHAS if only administering public housing.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceed 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or HCVs combined and is not PHAS or SEMAP troubled.

**Expand Access to Stable, Permanent Housing**

Mountain Projects, Inc. continues to fully utilize existing Housing Choice Vouchers to assist households experiencing homelessness or housing instability, prioritizing families with urgent needs as resources allow. While funding shortfalls have limited new voucher issuance at times, existing vouchers remain actively managed to support housing stability for current participants. Implementation of a Project-Based Voucher program in Haywood and Jackson Counties has been limited due to shortfall status and federal funding constraints. MPI continues to monitor local housing needs and remains prepared to pursue PBV opportunities when funding and program conditions allow. MPI maintains strong referral relationships with local shelters and advocacy organizations, including Pathways, HERE of Jackson, REACH, NC DHHS, and Centers for Domestic Peace. In 2026, MPI partnered with Centers for Domestic Peace to administer a Safe at Home grant through the North Carolina Coalition Against Domestic Violence, prioritizing housing assistance and supportive services for survivors of domestic violence and other households with urgent housing needs. Landlord outreach and engagement remain ongoing through regular communication and problem-solving, supporting voucher success rates and continued landlord participation in the HCV program.

**Promote Financial and Housing Self-Sufficiency**

The Family Self-Sufficiency program remains a strong and growing component of MPI’s housing strategy. As of 2026, enrollment has exceeded the annual goal of 25 families, with 28 participants currently enrolled and additional enrollments anticipated. As a five-year program focused on long-term outcomes, graduations may vary by year; however, several participants are making steady progress and graduations are anticipated. MPI provides ongoing guidance related to budgeting, credit improvement, and financial planning to support housing stability and reduce long-term reliance on rental assistance.

**Facilitate Homeownership for Low-Income Families**

MPI continues to advance homeownership opportunities through the HCV program and has reached a milestone of 10 HCV households achieving homeownership. In 2026, one family has already transitioned to homeownership, supporting the annual goal of assisting two families per year. MPI is also working with approximately 15 to 20 prospective households to build readiness for homeownership through counseling, financial planning, and coordination with local and regional partners. Families interested in homeownership receive education and referrals related to programs such as the HCV Homeownership Option, Smoky Mountain Housing Partnership, and self-help housing initiatives.

**Strengthen Community Partnerships**

MPI actively maintains and expands community partnerships to improve outcomes for low-income households. In 2026, MPI partnered with Blue Ridge Health to host a community healthcare screening event for Medicaid recipients and other low-income residents. MPI also partnered with the Nonprofit Internship Program in 2026 to host an eight-week intern within the HCV program, supporting workforce development and program capacity.

Mountain Projects, Inc. is committed to ensuring the safety, dignity, and housing stability of applicants and participants in the Housing Choice Voucher program and other housing programs administered by the agency. In compliance with the Violence Against Women Act (VAWA), Mountain Projects maintains policies and procedures to protect individuals who are victims of domestic violence, dating violence, sexual assault, or stalking.

In accordance with VAWA, victims are not denied admission to housing assistance or terminated from participation in the program based on their status as a victim or due to acts committed against them by an abuser. Housing assistance will not be terminated, nor will eviction be pursued, solely as a result of domestic violence, dating violence, sexual assault, or stalking.

Mountain Projects provides information regarding VAWA protections to applicants and participants at program admission, annual recertification, and upon issuance of a notice of termination. VAWA-related materials are also posted in agency offices and are made available upon request. These materials include HUD's Notice of Occupancy Rights under VAWA (Form HUD-5380), the Certification of Domestic Violence, Dating Violence, Sexual Assault, or Stalking and Alternate Documentation (Form HUD-5382), the PHA's emergency transfer plan, and HUD's Emergency Transfer Request for Certain Victims of Domestic Violence, Dating Violence, Sexual Assault, or Stalking (Form HUD-5383). Information for the National Domestic Violence Hotline and contact information for local victim advocacy organizations are also provided.

Staff are trained on VAWA requirements, confidentiality standards, and trauma-informed practices. All information related to an individual's status as a victim is kept strictly confidential and is disclosed only with the individual's written consent or when required by law. When documentation is required, it may include a signed self-certification, police or court records, or a statement from a service provider, attorney, or medical professional.

Victims residing in housing assisted by Mountain Projects have the right to request an emergency transfer when necessary to protect their health or safety. Emergency transfer requests are processed promptly, subject to eligibility and housing availability.

Mountain Projects works closely with community partners to support victims and expand access to housing and supportive services. In 2026, the agency is actively partnered with Centers for Domestic Peace through the Safe at Home grant administered by the North Carolina Coalition Against Domestic Violence, prioritizing housing assistance and referrals for survivors of domestic violence.

1. The Plan is consistent with the applicable comprehensive housing affordability strategy (or any plan incorporating such strategy) for the jurisdiction in which the PHA is located (24 CFR § 91.2).
2. The Plan contains a signed certification by the appropriate State or local official (form HUD-50077-SL) that the Plan is consistent with the applicable Consolidated Plan, which includes any applicable fair housing goals or strategies, for the PHA's jurisdiction and a description of the way the PHA Plan is consistent with the applicable Consolidated Plan (24 CFR §§ 91.2, 91.225, 91.325, and 91.425).
3. The PHA has established a Resident Advisory Board or Boards, the membership of which represents the residents assisted by the PHA, consulted with this Resident Advisory Board or Boards in developing the Plan, including any changes or revisions to the policies and programs identified in the Plan before they were implemented, and considered the recommendations of the Resident Advisory Board (24 CFR 903.13). The PHA has included in the Plan submission a copy of the recommendations made by the Resident Advisory Board or Boards and a description of the way the Plan addresses these recommendations.
4. The PHA provides assurance as part of this certification that:
  - i. The Resident Advisory Board had an opportunity to review and comment on the changes to the policies and programs before implementation by the PHA;
  - ii. The changes were duly approved by the PHA Board of Directors (or similar governing body); and
  - iii. The revised policies and programs are available for review and inspection, at the principal office of the PHA during normal business hours. Where possible, PHAs should make documents available electronically, for public inspection upon request.
5. The PHA made the proposed Plan and all information relevant to the public hearing available for public inspection at least 45 days before the hearing, published a notice that a hearing would be held and conducted a hearing to discuss the Plan and invited public comment. The PHA ensured all notices and meetings provided effective communication with persons with disabilities and further provided meaningful language access for persons with Limited English Proficiency (LEP).
6. The PHA certifies that it will carry out the public housing program of the agency in conformity with Title VI of the Civil Rights Act of 1964 (42 U.S.C. 2000d-2000d-4), the Fair Housing Act (42 U.S.C. 3601-19), Section 504 of the Rehabilitation Act of 1973 (29 U.S.C. 794), Title II of the Americans with Disabilities Act (42 U.S.C. 12101 et seq.), the Violence Against Women Act (34 U.S.C. § 12291 et seq.), and other applicable civil rights requirements, and that it will affirmatively further fair housing in the administration of all HUD programs. In addition, if it administers a Housing Choice Voucher Program, the PHA certifies that it will administer the program in conformity with Title VI of the Civil Rights Act of 1964, the Fair Housing Act, Section 504 of the Rehabilitation Act of 1973, Title II of the Americans with Disabilities Act, the Violence Against Women Act, and other applicable civil rights requirements, and that it will affirmatively further fair housing in the administration of all HUD programs.
7. The PHA will affirmatively further fair housing, in compliance with the Fair Housing Act, 24 CFR § 5.150 et seq., 24 CFR § 903.7(o), and 24 CFR § 903.15, which means that it will take meaningful actions, in addition to combating discrimination, that overcome patterns of segregation and foster inclusive communities free from barriers that restrict access to opportunity based on protected characteristics. 9. The PHA will comply with the prohibitions against discrimination based on age pursuant to the Age Discrimination Act of 1975.
10. In accordance with the Fair Housing Act, the PHA will not base a determination of eligibility for housing on marital status and will not otherwise discriminate because of sex.
11. The PHA will comply with the Architectural Barriers Act of 1968 and 24 CFR Part 41, 'Policies and Procedures for the Enforcement of Standards and Requirements for Accessibility by the Physically Handicapped' for people with physical disabilities.
12. The PHA will comply with the requirements of Section 3 of the Housing and Urban Development Act of 1968, Employment Opportunities for Low-or Very-Low Income Persons, and with its implementing regulation at 24 CFR Part 135.
13. The PHA will comply with the acquisition and relocation requirements of the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970 and implement the regulations at 49 CFR Part 24 as applicable.
14. The PHA will take appropriate affirmative action to award contracts to minority and women's business enterprises under 24 CFR 5.105(a).
15. The PHA will provide the responsible entity or HUD any documentation that the responsible entity or HUD needs to carry out its review under the National Environmental Policy Act and other related authorities in accordance with 24 CFR Part 58 or Part 50, respectively.
16. With respect to public housing the PHA will comply with Davis-Bacon or HUD determined wage rate requirements under Section 12 of the United States Housing Act of 1937 and the Contract Work Hours and Safety Standards Act.
17. The PHA will keep records in accordance with 2 CFR 200.302 and facilitate an effective audit to determine compliance with program requirements.
18. The PHA will comply with the Lead-Based Paint Poisoning Prevention Act, the Residential Lead-Based Paint Hazard Reduction Act of 1992, and 24 CFR Part 35.
19. The PHA will comply with the policies, guidelines, and requirements of 2 CFR Part 200, Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Financial Assistance, including but not limited to submitting the assurances required under 24 CFR §§ 1.5, 3.115, 8.50, and 107.25 by submitting an SF-424, including the required assurances in SF-424B or D, as applicable.
20. The PHA will undertake only activities and programs covered by the Plan in a manner consistent with its Plan and will utilize covered grant funds only for activities that are approvable under the regulations and included in its Plan.
21. All attachments to the Plan have been and will continue to always be available at all locations that the PHA Plan is available for public inspection. All required supporting documents have been made available for public inspection along with the Plan and additional requirements at the primary business office of the PHA and at all other times and locations identified by the PHA in its PHA Plan and will continue to be made available at least at the primary

business office of the PHA and, where possible, should be made available for public inspection in an electronic format.

22. The PHA certifies that it is following all applicable Federal statutory and regulatory requirements, including the Declaration of Trust(s).
